<u>REPORTS</u>

Auditor's Report, Year End June 30, 2008 (Handout: 4.a.a) Auditor's Report, 2006-07 (Handout Exhibit: 3.a)

Mr. Doug Kerkoch, and Mr. Larry Nelson of Kerkoch Katter & Nelson, LLP Certified Public Accountants, reviewed highlights of the audit and reported that all state requirements were in compliance for the 2007-08 college audit. The auditors gave the college a "Clean Opinion" noting the high fiscal services standards and exemplary support of the college's financial departments – accounts payable, payroll and financial aid –

- Jim Jones-Vice President & Chief Financial Officer
- David Dona-Associate Chief Financial Officer
- Lisa Bloyer-Accounting Manager
- Lori Ortiz-Payroll, and
- Jan Fisher-Accounts Payable.

The Board of Directors' and President Middleton, thanked and complimented the entire fiscal services staff for their good work.

Revenue and Expenditure Forecast (Handout: 4.b)

Mr. David Dona-Associate Chief Financial Officer, reviewed the key assumptions for 2009-10;

- Property taxes + 5% (lowest in 10 years)
- Prior year taxes + 6%
- \$1.50 increase for in-district tuition
- 4% increase in out-of-district/state tuition
- 2% enrollment increase
- \$250k transfer-in from PERS Reserve
- 3% increase in staff positions
- 12% increase in health insurance
- 2%-3.5% inflationary expenditure increase

2010-11 and 2012-13:

- CCSF Appropriation for 2011-13 biennium of \$509m (+5%)
- Property taxes +5% 2010-11, +6% 2011-13 biennium
- Prior year taxes +6%
- \$1.50 increase for in-district tuition
- 4% increase in out-of-district/state tuition
- \$250k transfer-in 2010-11, \$300k transfer-in 2011-13 biennium from PERS Reserve
- 0.5% increase in staff positions
- 12% increase in medical insurance
- 2%-3.5% inflationary expenditure increase
- No income yet from alternative resources

Financial Statements (Exhibit: 6.a)

The Board of Directors' were apprised of the December 2008 Financial Statements.

The Broadside (COCC Student Newspaper) (Handout: 6.b)

Erin Marlow-Advisor for The Broadside (student newspaper) and John MacAulay-Editor-In-Chief gave an update of the goals and progress of the paper. Mr. MacAulay reported that the newspaper is now a weekly publication.

Enrollment Recruiting Materials (Handout: 6.c)

Mr. Ron Paradis-Director of College Relations reviewed that every five years, the college does a "redo" of recruiting materials. He distributed new admissions recruiting material that's built around the theme/slogan - "The Best Place to Further Your Education: Period!"

Institutional Effectiveness (Exhibit: 6.d)

Exhibit: 6.d provided information on Latino and Native American students.

Upcoming Board Elections (Exhibit: 6.e)

Mr. Ron Paradis reviewed that four of the seven zones (1, 2, 3, & 4) for COCC Board of Directors positions are "up for election" on the upcoming May 2009 ballot.

Update on Winter Term Enrollment

Ms. Alicia Moore-Dean of Student and Enrollment Services, gave a preliminary enrollment report for winter quarter that showed head count numbers up from last winter by 24% and FTE (full time equivalent) numbers are up 32%.

The Board of Directors were apprised of the "Financial Condition" which includes:

OLD BUSINESS:

Update: 2009-11 State Budget & Capital Projects Proposal

President Middleton reported that the Legislative Session has begun in Salem. He reviewed the "good news" and the "bad news" -

- Economic projections are expected to worsen;
- The Governor's proposed budget for community colleges of \$485M is down 3% from the last biennium – but is still the "hoped for" amount;
- Growing support among Legislators for a higher allocation for community colleges;
- Potential "deferred maintenance projects" to be funded;
- > COCC's capital projects list includes a Technology Center.
